### **ADMISSION TO THREE YEAR B.A./B.SC./B.COM/BBA/BCA (GENERAL) COURSE PART-SECOND, SESSION 2013-14**

It is hereby notified for the information of all concerned that admission to **PART-SECOND** of the Three Year B.A./B.Sc./B.Com./BBA/BCA (General) Course for the academic session **2013-14** in the Government/Private Degree Colleges affiliated to the University of Jammu shall be made as under:-

In case the seats are available, the Principals may grant late admission on payment of late fee as under:-

c) The Vice-Chancellor may consider grant of late admission for one month only after the expiry of last date as per (b) above on payment of Rs.1630/- subject to the condition that wherever income of a candidate's parents is Rs. 3630/ or below, she/he be exempted from payment of Rs. 1630/-. However, late fee shall be charged in such cases as prescribed at (b) above.

**Admission in the above course shall be made irrespective of the holidays or vacations.**

**The regular teaching work of the class shall begin immediately after closure of admission without late fee.**

**A candidate who is placed under re-appear category in one subject only in the Three Year B.A./B.Sc./B.Com/B.B.A/B.C.A Course Part-I examination shall be eligible to seek provisional admission/permission to the B.A./B.Sc./B.Com/B.B.A/B.C.A Course Part-II at his/her own risk and responsibility subject to the condition that the candidate has qualified the Hr Sec. Part II examination in full subjects. And in such cases, the candidate shall qualify the subject in which he/she has been placed under re-appear category within the permissible statutory chances falling which his/her provisional admission to the next higher class/examination shall stand cancelled.**
